#### Issue or Topic: Lakewood Rentals

Brought to Attention by: Maureen/Kelly

- Two companies have Lakewood owner clients renting out their homes and listing our lakefront as an amenity. The 2 homeowners and the companies were emailed that they should remove the lakefront from their advertised list of amenities.Cottage Keepers never responded to email about home owner offering lakefront access. Homeowner Obrochta refused to comply. VRBO says we have to talk to homeowner. They are not responsible. Homeowner Jones did not respond.
- 2. Board can make rules but cannot make amendments to Covenants without 75% member approval.
- 3. Eric suggested a motion that Board/Association does not endorse commercial use of our lakefront and will explore options in the future to enforce the Board's rules. May pursue amendment in the future to make it more enforceable.

- 4. Cease and Desist order to owners and VRBO and Cottage Keepers can follow a new amendment.
- 5. Should we consider an amendment in the future to restrict rental of homes?
- 6. Special session to consider an amendment? We should look at updating all Covenants and Restrictions.

# Issue or Topic: Creating Building Standards

Brought to Attention by: Maureen/Kelly

- 1. Other associations like Lake Arrowhead requires submission of plans and dictates colors for their members.
- 2. Lakewood has garages/outbuildings going up that are unsightly, using a variety of building materials and all sizes.
- 3. Covenants are not specific and are open to interpretation of homeowner.
- 4. Lakewood homes were built economically, not high-end materials. Left door open to interpretation of what can be added onto the property.
- 5. Advisory committee had discovered that Lakewood can grandfather the existing buildings and make new rules for construction guidelines going forward.
- 6. Motion to explore more strict building code in the Covenants while respecting what has already been established with a vision of creating what will be acceptable in the future.
- 7. This will add a substantial administrative layer to the Board going forward.
- 8. Bring ideas to next meeting for Amendment for Building Standards and Amendment for Rentals.
